Whereas, the Village Board does change and establish fees from time to time as authorized by the Municipal Code; and

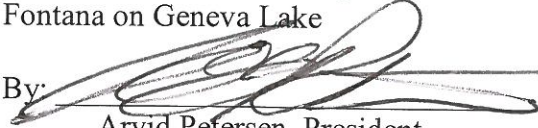
Whereas, the Village Board has determined that the Finance Committee recommendation to amend the Resident Parking Sticker fee needs to be authorized;

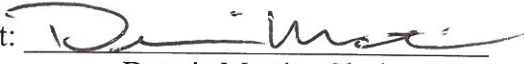
These fees shall remain in force until again set by the Village Board.
