### Quarry Development Draws Curiosity

Over the past month the Cliffs of Fontana development, located just off Highway 67 and across from the Village Hall, generated enough curiosity to bring in some new faces inquiring about the project. For all of those curious residents, who simply have not had the time to stop by the Village Hall, call or follow the project from its inception, here are some facts about the quarry project:

- 66 single-family homes
- Price point in the mid-\$500,000 range
- Stabilization of the eroding quarry cliffs
- Deluxe landscaping plan
- TID project to generate approximately \$35 million in increment

PAR Development achieved both the Plan Commission's and Village Board's endorsement for the 66 single-family home development after spend-

ing the last two and a half years in public meetings and hearings.

- January 31, 2005, the former quarry owner, the Audino family, presented the Certified Survey Map (CSM) to the Plan Commission.
- February 7, 2005, the Village Board approved the CSM to divide the property's upper ridge, approximately 10 acres, from the quarry, approximately 24 acres.
- March 1, 2005, PAR Development, the new owners of the quarry, presented their initial concept to the Plan Commission, which included 66 town homes represented by 33 buildings on the quarry portion of the lot.
- July 2, 2007, after countless public meetings and hearings PAR received final approval to develop a 66 single-family unit subdivision.

To paraphrase Charles Dickens ... "A thing constructed can only be loved after it is constructed." Construction needs to get a little ugly and dirty before we can all appreciate the finished product. Next summer the community will see a stabilized, safe and heavily landscaped cliff creating a beautiful view from both the lake and Highway 67.

The summer has passed and with it the surge in police calls for service. As of September 15, 2007 we had

handled 1,935 calls compared to 1,890 calls at the same time in 2006.

Officers Mark Chalchoff and Derrick Goetsch will be teaching the "COUNTERACT" counter drug abuse program in the grade school starting in January. This program replaces DARE. School is open and we closely monitor the traffic around the school and bus stops. Please drive extra cautiously when students are coming and going from school.

We have seen a big increase in identify theft type crimes and Internet fraud this year. The most common crime is where someone will send you what they want you to believe are valid bank/travelers checks and ask you to cash them at your bank. You then keep a percentage as a reward and send the remaining money somewhere else. In the end, the checks are found to be fake and you end up paying back to the bank the full amount of the money you cashed them for. Please call us if you are approached to do this and if you receive an email to do this, delete it.

If your credit card is lost or stolen and used illegally contact us promptly to save your credit rating.



dominant in this region.

Among other things, the Duck Pond Recreation Area began life as a treatment site for the Village's waste water. The treated water filled the large basins on the property and as a result created a fantastic water fowl habitat. Over the years, the Village water treatment needs have changed, but our beloved name for the area still remains - Duck Pond.

During the last 12 months, a master plan for the Duck Pond property has been developed which aims to bring back the wetland habitat once there, and also to restore the prairie, savannah and woodlands once

The illustrative plan above provides a guide to the future of the Duck Pond area. Much of the 100-plus acre site is planned to consist of native landscape restoration areas. In addition to the native areas, and the recreation fields which currently exist, the plan includes nature paths, dog walking trails and training areas, bike trails and tennis courts. Afull size plan for the Duck Pond Recreation Area Master plan currently is on display at the Village Hall.

### Duck Pond Bicycle/Pedestrian Trail Underway

When asked for the secret of how to live a long life, our 33rd President, Harry S. Truman, responded, "Take a two-mile walk every morning before breakfast."

Walking is by far the number one form of human transportation in the world today. People of all ages and backgrounds can do it and it makes up at least some portion of every trip we make on a daily basis. Unfortunately, in our automobile dependent society, the walking portion of most of our trips is now limited to that short segment from the house to the garage. The recognized cause for this phenomenon is that walking as a transportation choice has historically received very little attention in the planning, design and development of our communities. Here in Fontana that is no longer the case.

One common objective in each of the recent CDA projects was the establishment of a comprehensive network of pedestrian and bicycle routes. Specifically, the goal has been to ensure that destination points like Reid Park, the municipal beach, the lakefront, Fontana Elementary School, the Village Center, and the Duck Pond Recreation Area were all linked together via a combination of bicycle routes, sidewalks, pedestrian paths and trails.


The CDA's opening project included a new sidewalk from State Highway 67 all the way to the Fontana Elementary School along the south side of Main Street. That following year, as part of the State Highway 67 improvement project, a pedestrian trail was built that runs the entire length of the highway corridor from Dewey Avenue to Wild Duck Road. With the current reconstruction of Wild Duck Road now well underway, one of the last remaining links, needed from the highway to the Duck Pond Recreation Area, will be added before the snow flies this winter.

To ensure the safety of pedestrians who will be using the future path, it was designed to be physically separated from the roadway. By opting not to go with a simple bike lane divided from the active traffic lanes by nothing more than a painted white line, dangerous interactions with the heavy trucks and equipment that also use the road will be avoided. At the intersection of Wild Duck and Dade, the path travels through an underpass for safety reasons as well.

The incorporation of the underpass at the intersection was also integral to the goal of keeping the incline of the path as gentle as possible and thus ensuring accessibility for all users.

With another crucial connection about to be finished, a person will soon be able to walk the entire distance from the Pubic Beach to the Duck Pond Soccer Fields without ever having to set foot on a road outside of a crosswalk. Fontana's goal of becoming a "walkable" community is now within walking distance.

### DPW Offers Services

### **Leaf Vacuum Service**

Dates of Service:" Approximately October 15 to December 7. Note: Dates may vary depending on leaf volume and snow accumulation.

Schedule: The entire Village will be covered on a weekly basis starting at the northern village limits, progressing through downtown and Country Club Estates, finishing along South Lake Shore Drive at the eastern village limits. Due to the unpredictability in leaf volume, it is impossible to schedule a specific day each week for a particular street or subdivision.

Basic Rules: Property owners must deposit leaves no farther than 5 feet from the street, but NOT on the pavement itself. Leaf piles that are placed in the roadway are subject to a fine. Any leaves that are not picked up because they are outside the 5-foot area should be raked to within the 5-foot area for pickup the following week. This service DOES NOT include the removal of grass clippings. Please make sure that leaf piles are free of any rocks or twigs.

### **Curb-Side Chipping**

Schedule: Chipping will be conducted during the LAST FULL WEEK of each month, with the exception of December, January and February, when chipping services will only be conducted as necessary.

Basic Rules: The Village does not handle brush from ANY lot clearing activities; no tree material larger than 6 inches in diameter will be accepted for chipping; piles that contain non-recyclable material WILL NOT be handled; all materials to be chipped must be stacked with the butt-ends facing the street; a fee of \$2.50/minute will be incurred after the first 15 minutes of each month, or for any pile that is too large to chip.

### **Compost Information**

The Village has a limited supply of world class compost that can be purchased for \$10/cubic yard. A \$50 charge will be added to any deliveries. This material is great for gardens, top dressing of land-scape beds, or grass seeding. In addition, we are working on ways to sell compost by they bag which will be extremely beneficial for flower pot plantings.

### **Contractor Services**

Please note that all contractor services (tree trimming or removal, lawn mowing, etc. shall be responsible for removing all cut debris and yard waste generated as a part of their service. Material may be taken to the Village compost area for free.
