#### Ordinance No. 01-06-03-1

Ordinance to Amend Ordinance Designating Municipal Election Wards
Village Clerk Smith prepared the Ordinance designating Ward IV. An additional election
ward was necessary to create due to the County Re-districting after the 2000 US Census

and after the Thomas Schmidt and Dan Butvill Annexation from the Town of Walworth.

Village Clerk Smith explained that the Village Board has adopted a Resolution that combines Ward I, Ward III and Ward IV for one polling place. The VOF polling location is in the Village Hall Meeting Room.

## Lake Geneva Yacht Club Utility Lease

## F/W WPCC 2003 – 2004 Farm Lease with Ellis Farms, Inc.
