Community Development Authority [CDA] Interim Funding - Trustee Turner

Trustee Turner stated that the CDA will need money to proceed with planning, pay the Executive Director, etc. Trustee Turner has asked for a letter from Assessor Coplien stating his best estimate of the increment that TIF should have.

MOTION was made to recommend and appoint Cliff Semmler as Interim Recreation Director for a limited period of time with hours not to exceed 40 hours a week, but more likely fall in the 20 – 30 hour range per week, at the same pay scale that Bob Kret was getting paid less benefits. MOTION carried without negative vote.

Lake Geneva / White River Dam Rehabilitation Project – Trustee Grabow
Trustee Grabow submitted a memorandum from Lake Geneva Water Commission
directed by Daniel S. Winkler outlining the estimated cost by Phase I, II, and III, totaling
\$63,242.00. Village of Fontana's percentage will be 25%.
It was unanimous recommendation of the interview committee that the Common Council
approve URS of Madison, WI as the Geneva Lake Dam Consultant.
