REGULAR VILLAGE OF FONTANA BOARD OF TRUSTEES MEETING

Monday, March 2, 2004

President Whowell noted at 6:02 pm that the Board was already in session from a prior open meeting.

Trustees Present: Cole, Geye, O'Connell, Petersen, Turner, and President Whowell

Trustees Absent: Bromfield

Open Public Hearing on Impact Fees

Jim Mann, of Ehlers and Associates gave an explanation of the calculations for impact fees utilizing East and West impact fee zones. Based on Fontana's Master Plan, 656 more units were planned for the next 20 years, especially in the Westerly part of the Village.

Trustee Turner: Impact fee don't work for Fontana because

- Assumes that growth will be there.
- Utility system is not designed to go westerly
- Impact fees will not cover the actual cost (ie Tracy Project)
- Chapter 17 of the Municipal Code meets the village's needs

Attorney Thorpe: Can impact fees be used for specific uses? Yes, said Mann, one can pick and choose which project utilizes impact fee funding.

Skip Bliss: Impact Fees would not work for the Village and did not desire to speed up growth. Bliss said cost should be borne by developer for growth.

Trustee Petersen: What are the alternatives? 57 wells and 57 septic for Tracy

Jim Feeney: The Finance Committee's view was that there was going to be growth in Fontana.

Trustee Turner: 435 planned units and the cost of building Westerly caught everyone's attention when a closer look at the study was made.

Trustee Petersen: If we are not involved, other communities will.

Trustee Turner: Village should issue a bond and have it gradually paid back by property owners.

Bob Chanson: Chapter 17 is a great tool and is able to utilize control.

Jim Mann: Suggested not putting in a water tower until usage will make it necessary.

Trustee Geye: Would the Village be able to piecemeal impact fees in as the development evolved to greater dimensions? Yes, Attorney Thorpe said.

Trustee Geye: Should a Master Plan be made on the westerly area of Fontana?

President Whowell: Properties will change. It is more of a question of what shape the Village will be in order to maintain its character.

Public Hearing Closed.

Trustee Cole - It appeared unanimous that impact fees should not be adopted. Instead, use the benefits of Chapter 17 of the Municipal Code.

President Whowell: Not the right time for impact fee implementation.

Jim Mann: Special Assessment authority can be used.

Jim Mann: Agrees that Turner is right; impact fees are not best avenue for communities that do not want a lot of growth.

President Whowell: Impact Fee investigation has been a due diligence effort.

Attorney Thorpe: Acknowledged that there was not a motion on impact fees. Matter failed for a

lack of a motion and was put off the table. No action taken

Plan Commission - President Whowell

Tracy Development Update

President Whowell briefed the Board on the Tracy presentation made at the Plan Commission Meeting of February 16, 2004. Discussion at length consisted of the following:

- Walworth Township wanted to know what Village of Fontana will do.
- Finance Committee questioned how to collect on water and sewer infrastructure costs
- O Should Fontana issue a bond and have property owners pay for infrastructure over 20 years
- Prompt action is needed in possible renegotiations between the Village of Fontana and Tracy
- o Rural septic well system shortfalls
- Walworth/Fontana water and septic needs
- O Speculation as to why John Tracy withdrew the Highlands Project

Flagship project efforts to work with Tracy would consist of Geye, Mike Bridwell, Craig Workman, and Dale Thorpe. Trustee Geye instructed to give John Tracy a call on this matter.

Jerry Coplien/Bernie Laird - Proposal to Complete Property Assessment Revaluation

Tax Assessor Jerry Coplien will retire in Aug 2004; however he will assist in the tax re-evaluation which is due for completion by August of 2005. Highlights of his suggested action plan were:

- ✓ Records updated on computer by 8/05
- ✓ Hire Bernie Laird. Bernie started in the late 1960's in Fontana and is very familiar with the Village. Bernie will be doing Lake Geneva's and Linn's revaluations
- Assessor Coplien completed a portion of the re-evaluations and will remain on staff until it is done
- ✓ Village of Fontana Board will decide on the re-evaluation percentage.
- ✓ Finance will give recommendation at the April 2004 Board meeting
- ✓ Once the new system is completed, property tax information will be available on the Web
