There was discussion about growing and joining the events that included the Santa and Tree Lighting at Pioneer Park the day after Thanksgiving and the Santa event at the Abbey Resort the Saturday after Thanksgiving. The item will be placed on the next Tourism Commission agenda for further discussion.

Discussion or Action on Rain Barrel Rebates

Loomer stated the public works committee made a recommendation and the Village Board approved the rain barrel rebate program and recommended the refunds come from the Tourism Commission. Rain barrels help keep the lake clean by reducing erosion and runoff during rain events.

<u>Commissioner Dolan/Commissioner Baumann 2nd made a MOTION to approve a \$20 rebate for Village of</u> Fontana residents that provide proof of purchase of a rain barrel, up to a maximum of \$2,000. The MOTION carried without negative vote.
