President Whowell called the Special Village Board meeting to order at 5:00 pm in the Village Hall, 175 Valley View Drive, Fontana, Wisconsin.

Spadoni remained in the closed session of the Village Board to provide an update on contract negotiations with the police officer's union.

Geye/Turner 2<sup>nd</sup> made a MOTION to adjourn the Closed Session at 6:38 p.m. and to reconvene in open session, and the MOTION carried without negative vote.

President Whowell announced that the Board was still in session at 6:38 pm.

Trustee Petersen left the meeting at 6:39 pm.

### General Business - President Whowell

Approval to Advertise for DPW Employee

Turner/O'Connell 2<sup>nd</sup> made a MOTION to advertise for a new Department of Public Works employee, and the MOTION carried without negative vote.

### Update on Wausau Insurance Denial of Jacobson Claim

Wausau Insurance Technical Claim Specialist Diane Schwarzhuber reported the Village Board would be taking a risk of setting a precedent for future claims if it approves the payment of Jacobson's \$500 home owner's insurance deductible. Schwarzhuber reported that if the Village Board approved the deductible payment, the Village Attorney should consider drafting some type of release to insure the Village is protected from losses that occurred on the date of the incident, and for any corresponding damage that may be alleged in the future.

Geye/O'Connell 2<sup>nd</sup> made a MOTION to deny the request from Jacobson to pay his \$500 deductible, and the MOTION carried on a 2-1 vote, with Geye and O'Connell voting yes, Turner voting no, and Whowell abstaining.

Amendment to Section 18-151 (c). Existing Nonconforming Buildings of the Village of Fontana Municipal Code

Hayden-Staggs stated language changes discussed at the Village Board's November 1, 2004 meeting were incorporated into Ordinance 11-01-04-1.

Geye/Turner 2<sup>nd</sup> made a MOTION to approve Ordinance No. 11-01-04-1, and the MOTION carried without negative vote.
