**Public Hearing – 2022 Village of Fontana Municipal Budget**

**Resolution No. 11-23-21-01 Adopting the Tax Rate for 2021 and Collected in 2022**

Loomer stated the mill rate for 2022 will be 2.846; a decrease of approximately 11% from 2021. Trustee Pappas/Trustee Prudden 2<sup>nd</sup> made a MOTION to approve Resolution 11-29-21-01, adopting the tax rate for 2021 and collected in 2022, as presented. The MOTION carried without negative vote.
