General Business

Approval of Minutes

Trustee Petersen/Trustee Prudden 2nd made a MOTION to approve the minutes from November 1, 2021, November 23, 2021 and November 29, 2021, as submitted, and the MOTION carried without negative vote.

Village Treasurer's Report, Vendor Report, & Payroll Overtime Report

<u>Trustee Livingston/Trustee Petersen 2nd made a MOTION to approve the Vendor Report and Payroll</u>

Overtime Report as distributed for November, and to place it on file for the audit, and the MOTION carried without negative vote.

Approval of Village and Utility Payables

Trustee Prudden/Trustee Livingston 2nd made a MOTION to approve payment of the Village and Utility payable list, as presented, and the MOTION carried without negative vote.

General Business - President Kenny

Introduce New GLEA Executive Director Jake Schmitt

New GLEA Executive Director Jake Schmitt introduced himself and stated he looks forward to working with all municipalities around the lake.

Discuss Refugee Housing at St. Benedicts Church

Father Mark from St. Benedicts Church stated they are working with Lutheran Social Services on housing refugees at the church. At this time, they are not sure of the timing and the exact number of possible refugees they would host. The most people the Church can host would be twelve and the longest period of time would be one year. Trustee Prudden mentioned having the Fire Chief do a walk-through inspection prior to the start of housing,

2021 Audit Contract with Sitzberger CPA's

Loomer stated this is for the annual audit.

<u>Trustee Petersen/Trustee Prudden 2nd made a MOTION to approve the 2021 Audit Contract with Sitzberger CPA's</u>, for an amount not to exceed \$25,500, and the MOTION carried without negative vote.

Election Inspector Appointments for 2022-2023

Trustee Petersen/Trustee Livingston 2nd made a MOTION to appoint Ann Barth as Chief Election Inspector, Kathy Walsh as Alternate Chief Election Inspector, Joanne Kristoffersen-D and Paul Kristoffersen-D as an Election Inspectors; and reappoint John Dudek, Jane Klockars-R, Keith Nuzzo, Robin Nuzzo, Susan Olson-D, Susan Rowland-R, Mickey Springer-R, Donna Niemeyer and Phil Niemeyer as Election Inspectors for the 2022/2023 calendar years.

Discuss Abbey Provident Resort Request for Townhomes

Attorney Donner with Abbey Provident Resort stated they had submitted a concept plan and there were some questions in regard to the submitted plan being inconsistent with the current comprehensive plan. Attorney Donner stated on November 29, 2021 he submitted a letter to attorney Thorpe. Attorney Thorpe stated he did receive the letter and advised there are some technical problems with the comprehensive plan and master plan. Attorney Thorpe stated there are some possible options if the Village Board chooses to go that route. Trustee Prudden questioned what can be done to make this project work. Attorney Thorpe stated there is more to consider than just this project including the unique qualities to the downtown zoning district. Thorpe stated he could look into how this project could comply with the use, however the more challenging issue will be complying with the setbacks.

<u>Trustee Petersen/Trustee Livingston 2nd made a MOTION to authorize Attorney Thorpe and staff to look at existing zoning methods and procedures and bring back to the Village Board expediently, and the MOTION carried without negative vote.</u>

Authorize Payment of Year-End Budgeted Invoices

Trustee Livingston/Trustee Petersen 2nd made a MOTION to authorize staff to prepay any 2021 payables that come in prior to the end of the year for budgeted expense invoices, and the MOTION carried without negative vote.

Authorize Reimbursement Transfer of \$1,000,000 from Utility Fund to General Fund

Trustee Petersen/Trustee Prudden 2nd made a MOTION to approve reimbursement transfer of \$1,000,000 from Utility Fund to General Fund, and the MOTION carried without negative vote.

Accept \$2,100 Donation from P3 for 2021 Triathlon

Trustee Livingston/Trustee Prudden 2nd made a MOTION to accept the donation of \$2,100 from P3 for the 2021 Triathlon, and the MOTION carried without negative vote.

Annual Holiday Gift Card Approval

Trustee Prudden/Trustee Livingston 2nd made a MOTION to approve the issuance of \$50 gift cards to Village employees for holiday bonuses in the same manner as previous years, and the MOTION carried without negative vote.

Consider Ordinance Creating Chapter 66-5(b)(5)(a) regarding Use of the Tunnel at Abbey Springs

Attorney Thorpe stated this ordinance is a result of a memorandum of understanding dating back some time that was previously approved by the Village Board. The memorandum of understanding was to have something on the books regarding use of the tunnel at Abbey Springs. The ordinance is being offered for adoption mirrors the previously approved memorandum of understanding.

Trustee Petersen/Trustee Prudden 2nd made a MOTION to approve ordinance 120621-01, regarding use of the tunnel at Abbey Springs, and the MOTION carried without negative vote.

Consider Ordinance Amending Chapter 14-65 to correct the Reference to Zoning Permit for Tree Removal

Loomer stated this amendment is to correct an incorrect reference.

Trustee Prudden/Trustee Petersen 2nd made a MOTION to approve ordinance 120621-02, correcting the

reference to zoning permit for tree removal, and the MOTION carried without negative vote.

Proposed Amendments to 18-199 regarding Sign Ordinance Amendment – Set Public Hearing

Loomer stated when the sign ordinance was rewritten last year there is conflict with internally illuminated signs. One section allows internally illuminated signs, and another section does not allow it. The amendment also removes the provision that allows electronic message signs.

Trustee Prudden/Trustee Livingston 2nd made a MOTION to set a public hearing for the proposed amendments to chapter 18-199 regarding the sign ordinance at the next scheduled Plan Commission meeting, and the MOTION carried without negative vote.

Proposed Amendments to Chapter 18-234 Zoning Board of Appeals – Set Public Hearing

Loomer stated the current ordinance requires two trustees to be on the Zoning Board of Appeals and that should be removed to state only citizen members.

Trustee Livingston/Trustee Prudden 2nd made a MOTION to set a public hearing for the proposed amendments to chapter 18-234 zoning board of appeals for the next scheduled Plan Commission meeting, and the MOTION carried without negative vote.

Consider Ordinance Amending Zoning Code Section 18-65(b), Regarding Temporary Outdoor Sales, and Creation of Section 18-65(j), Regarding Food and Beverage Vehicles, Carts, and Stands

Mich stated the purpose of the ordinance is to allow food and beverage vehicles, carts and stands for catering use only. Loomer stated Plan Commission recommended limiting the setback from the property line from ten-feet to five-feet.

Consider Resolution Adopting 2022-2027 Park and Open Space Plan

Public Works Committee - Trustee O'Neill

Update on Stormwater Management Planning

Village Engineer Terry Tavera stated that Loomer, Day, and him had met with the DNR at several of the sites to discuss permitting and cost sharing. The Shabbona Drive outfall project is moving forward and currently working on permitting. Tavera explained he is working with the DNR on projects located in the TID.

Update on S. Lakeshore Drive Reconstruction

Tavera stated he met with the contractor to go over the punch list items that are not complete. The project will remain open and punch list items are to be completed by the contractor prior to Memorial Day 2022.

Lake Street and Beach Parking Lot Reconstruction - Final Payment Recommendation No. 5

Tavera explained this is the final payment for Lake Street and Beach Parking lot reconstruction. Tavera has reviewed and recommends payment.

Trustee Livingston/Trustee Prudden 2nd made a MOTION to approve final payment recommendation No. 5 in the amount of \$5,000, and the MOTION carried without negative vote.

S. Lakeshore Drive Reconstruction - Payment Recommendation No. 13

Tavera explained this is a reduction in the retainage for repairs that still need to be completed. <u>Trustee Livingston/Trustee Prudden 2nd made a MOTION to approve payment recommendation No. 13 in the amount of \$25,000, and the MOTION carried without negative vote.</u>
