## Full-Time Firefighter Paramedic AND Part-Time Firefighter EMT / Paramedic

Fontana Fire Department is establishing 12-month eligibility lists for full time Firefighter Paramedic and part time Firefighter EMT/Paramedic employment opportunities.

Fontana Fire Department is a combination full-time, part-time, and paid-on-call Department providing emergency services to the Villages of Fontana, Walworth Township, and Williams Bay (EMS) with approximately 6,400 full-time residents and large seasonal increase. Fontana Fire Department responds to approximately 950 emergency calls per year in addition to providing public education, fire inspections, CPR training, and public assistance.

### Minimum Qualifications include:

- Wisconsin Paramedic (Full-Time) / Wisconsin EMT (Part-Time)
- Wisconsin Firefighter I Certification
- Valid Driver's License
- Successful completion of pre-employment physical, drug screen & background check.
- At least 18 years of age

### Preferred Certifications:

- Wisconsin Motor Pump Operator Certification / Aerial Certification
- Wisconsin Firefighter II Certification
- Wisconsin Fire Inspector Certification

### Full-time Employee Schedule and Benefits

- State of Wisconsin Firefighter Pension System (WRS)
- Health, Dental, and Life Insurance
- Paid Vacation and Sick Time
- Schedule - 24 hours on / 48 hours off with one 24-hour shift off (Kelly Day) per 27-day cycle.

**PART TIME - 2026 Hourly Rate - \$25.61 to 28.68 (Paramedic) / \$21.13 to \$23.66 (EMT)**

### Casual Part-time Schedule and Benefits (Firefighter/Paramedic OR Firefighter/EMT)

- 10-hour (day), 14-hour (overnight), or 24-hour shifts - 30 hours per month minimum
- State of Wisconsin Firefighter Pension System (WRS) after 1200 hours of work in a 12-month period
- Optional health insurance benefits after 1200 hours of work in a 12-month period

### Permanent Part-Time Schedule and Benefits (Firefighter/EMT)

- 36 hours per week – Three 24-hour shifts every two weeks
- State of Wisconsin Firefighter Pension System (WRS) at time of hire
- Optional health insurance benefits
