As a business that is related to lakes or as a lake user you have a special relationship with lakes. When lakes become threaten your relationship is jeopardized.

Geneva Lake has become threatened, it affects all of us who have any ties, emotional, financial or family connections to the lake. Geneva Lake is facing a very serious threat by a non-native aquatic invasive plant called a **starry stonewort**.

(https://dnr.wi.gov/topic/invasives/fact/starrystonewort.htm) It has been found in one isolated location in Geneva Lake, but if not address quickly it will spread throughout the lake and negatively impact the whole lake and its use.

We need to act quickly to prevent the spread of the starry stonewort. The Geneva Lake Environmental Agency (GLEA) and with the WI Department of Natural Resources have taken some unprecedented actions to control and hopefully eliminate it from the Geneva Lake. The reproductive part of the plant lives in the sediment. The best method of controlling the spread and eliminating it from the lake is to dredge the area where it has been found with the anticipation of removing the reproductive portions of this invasive plant. GLEA is organizing the dredging, obtaining permits and approvals, filling for grants and with your support will be funding the costs.

It has been estimated that the cost of the dredging, dewatering, and spoils removal would be around \$150,000. A WI. Department of Natural Resources grant of \$20,000 will be applied for to assist in controlling this invasive.
