Ordinance 030518-02

An Ordinance Amending Section 18-40. I. (i)(1), and Creating Appendices A, B, C and D to Section 18-40 of the Municipal Code of the Village of Fontana on Geneva Lake regarding Resort Business (RB) District.

WHEREAS, the Village Board does intend by this Ordinance to make certain amendments to the Village of Fontana on Geneva Lake Municipal Code.

NOW, THEREFORE, the Village Board of the Village of Fontana on Geneva Lake, Walworth County, Wisconsin, do ordain as follows:

SECTION 1.

To amend Section 18-40 I. (i)(1) as follows:

- (i) Signage regulations. The following sign regulations shall apply to the Abbey Resort Subdistrict in place of the equivalent regulations in article XII.
 - (1) Signs permitted within the Central Area and Peripheral Area without additional approval.
 - a. All existing signs, and replacement thereof, and their areas and locations pursuant to the sign inventory dated May 6, 2009 and on file with the village.
 - b. All signs included in the proposed sign upgrade packet dated _____ and on file with the village.

SECTION 2.

Appendix A. As referenced in Section 18-40 I. (b), and as attached hereto and incorporated herein by reference, Appendix A is hereby added to the conclusion of Chapter 18 of the Municipal Code of the Village of Fontana on Geneva Lake.

SECTION 3.

THE ABBEY VILLAS CONDOMINIUM SUBDISTRICT

Existing Uses at Abbey Villas Condominium, Fontana, Wisconsin

- 1. Apartment: residential buildings with 3-8 dwelling units, each of which is adjacent to at least one of the other units.
- 2. Home Occupations: service-oriented and/or home-based businesses secondary to residential use. Employees of the business must reside in the dwelling and customer visits to the residences are not permitted. *Note: Units 12A and 12B have home offices*.
- 3. Residential Garages and Sheds.
- 4. Residential Recreational Facilities such as swimming pools and swing sets.
- 5. On-Site Parking.
- 6. Stormwater Facilities.
- 7. Exterior Communication Devices such as satellite dishes.
- 8. Incidental Recreational Equipment Storage such as motor homes, kayaks and boats on a temporary basis.
- 9. Auxiliary Signs: signage of a non-commercial nature, such as "No Trespassing" or "No Lifeguard on Duty, Swim at Your Own Risk".
- 10. Free-Standing Signs: includes monument signs.
- 11. Essential Facilities: utility lines, sewer and water connections, Cable TV lines, etc.
- 12. Exterior Lighting: lighting of parking lots, common areas, etc.
- 13. Impervious Surfaces: driveways, parking lots, patios, surfaced playground and pool areas.
- 14. Landscaped Areas.

- 4. Parties, weddings and other social events (indoor and outdoor).
- 5. Hot Dog Stand.
- 6. Sales of Yacht Club merchandise, Marina merchandise and sundry sales of boating supplies.
- 7. Yacht Club events for members and their guests.

Miscellaneous Uses:

- 1. Launch ramp operations.
- 2. Winter ice skating and snowmobiling.
- 3. Fishing.
- 4. Scuba diving and swimming.
- 5. Periodic dredging to maintain the Marina.
