

**ORDINANCE NO. 051222-01**

**An Ordinance Repealing and Recreating Sections 34-76 through 34-78 and Repealing Sections 34-79 through 34-97 of the Municipal Code for The Village of Fontana-on-Geneva Lake.**

The Village Board of the Village of Fontana-on-Geneva Lake, Walworth County, Wisconsin, do ordain as follows:

**SECTION 1.**

Section 34-76 is hereby repealed and recreated to read as follows:

Section 34-76. Fire Department.

The Village of Fontana Fire Department is hereby established. The Department shall consist of a Chief and may include one or more Deputy Chiefs, one or more Operation Assistant Chiefs, one or more Captains and such other Fire Department and Emergency Service Personnel employees as may from time to time be appointed and hired pursuant to the Wisconsin Statutes and such other ordinances or policies as may be enacted by the Village Board or the Board of Police and Fire Commissioners for the Village of Fontana.

**SECTION 2.**

Section 34-77 is hereby repealed and recreated to read as follows:

Section 34-77. Chief of the Fire Department.

- a. The Chief of the Fire Department shall have command of the Fire Department, subject to the direction of the Village Board, Village President and the Village Administrator.
- b. The Chief of the Fire Department shall attend all fires, if possible, and supervise and direct all operations of the Fire Department.
- c. The Chief of the Fire Department shall sign all payment orders prior to payment orders being submitted to the Village Treasurer, shall order repairs as deemed necessary, shall manage the Fire Department budget and shall perform such other duties as provided by ordinance and as directed by the Village of Fontana.
- d. The Chief of the Fire Department may appoint a designee per Section 34-77 a. through c. for limited times when the Chief of the Fire Department is temporarily unavailable and for the limited purpose of managing Fire Department operations and to carry out the prior directives of the Chief of the Fire Department.

**SECTION 3.**

Section 34-78 is hereby repealed and recreated to read as follows:

Section 34-78. Employment of Fire Department Employees.

The Chief of the Fire Department shall develop a list of potential employees to be considered for employment by the Village of Fontana for the Fire Department. Said list shall be submitted to the Board of Police and Fire Commissioners for their consideration as required by Wisconsin Statutes at least once annually or as may otherwise be requested from time to time by the Board of Police and Fire Commissioners.

**SECTION 4.**


Sections 34-79 through 34-97 are hereby repealed in their entirety.

**SECTION 5.**

**EFFECTIVE DATE.** This ordinance shall be in full force and effect upon and from its passage, approval, and publication as required by law.
