Meeting of the Village of Fontana Police and Fire Commission

**Accept minutes of May 23<sup>rd</sup>, June 1<sup>st</sup>, June 13<sup>th</sup>, and June 18<sup>th</sup>, 2022 Meetings**

Haughey/Henning 2<sup>nd</sup> made a motion to approve the June 1<sup>st</sup>, 13<sup>th</sup>, and 18<sup>th</sup>, 2022 meeting minutes for the Police and Fire Commission and table the approval of the May 23<sup>rd</sup>, 2022 meeting minutes until they could be presented and finalized, and the MOTION carried without negative vote.

**Fire EMS Candidate Employment Interviews**

4. Jason McDaniel (full-time)
5. Cory Giese (full-time)
6. Liam Daly (part-time)
7. Kenyon Smith (part-time)

Any offers of employment to these candidates are contingent upon successfully completing a background investigation, physical examination, psychological examination, and a drug screening. MOTION carried without negative vote.

Henning/Tierny 2<sup>nd</sup> made a motion to recommend that the Village of Fontana Board of Trustees make a conditional offer of employment to candidates Liam Daly and Kenyon Smith as a part-time Fire/EMS employees.
