Hunting Regulations

The authorized hunters are expected to follow the parameters listed below in addition to the 2021 Wisconsin Deer Hunting Regulations. In the event the special parameters are more restrictive than the DNR, the hunters are expected to follow the more restrictive terms.

- o Limited hours for DPW/Compost Site.
- o Hunters MUST harvest a doe prior to harvesting a buck.
- Bow hunting will continue through the gun hunting season.
- o Hunting will terminate no later than January 31, 2022.
- No hunting within 100 yards of a human occupied dwelling without consent.
- If a wounded deer leaves the hunting zone the Fontana PD must be notified to assist with tracking. Fontana PD 262-275-2135
- Agents for the Village Property must secure the gates and post hunting signs during the hunting hours.
- All weapons must be secured in a case when hunters are leaving the zones.

No baiting of deer during the hunt.
 Hunters must report to Village staff number of deer harvested during the season.
