

**Ordinance 02-07-06-03**

**An ordinance to amend Sections 18-80 (c), 18-82 (c), 18-84 (c), 18-86 (c), 18-88 (c), 18-90 (e), 18-92 (c), 18-93 (c) and 18-94 (c) of the Village of Fontana Municipal Code to include clear cutting of a parcel under the Conditional Use Permit process**

The Board of Trustees for the Village of Fontana on Geneva Lake, Walworth County, Wisconsin do ordain as follows:




