

**Ordinance 07-06-11-01**  
**An Ordinance Amending Section 30-5 of the Village of Fontana Municipal Code**  
**Designation of New Municipal Election Wards.**

The Board of Trustees for the Village of Fontana on Geneva Lake, Walworth County, Wisconsin, do ordain as follows:

**Section 1.** Section 30-5 shall be amended to read as follows:

**Section 1.** Designation of Municipal Election Wards, pursuant to Section 5.15 (4) of the Wisconsin State Statutes, the Village of Fontana shall designate the following wards based on the results of the 2010 Federal Census of Population – Ward Report Forms & Map of Census Blocks, copies of which are attached hereto:
