

Ordinance 070708-01

An ordinance repealing and recreating Section 54-161 (5)(4)and(5) and Section 54-165(a) of the Village of Fontana Municipal Code

The Board of Trustees for the Village of Fontana on Geneva Lake, Walworth County, Wisconsin do ordain as follows:

Section I. Sections 54-161(5)(4) and (5) are hereby repealed and recreated to read as follows:

Section 54-161 (5) *Parking lot fees.*

4. Upon payment of such annual fee as may be determined by the board, a resident or property owner of the Big Foot School District, or employee of a current business on Lake Street or Third Avenue from the corner of Lake Street to the boat/trailer lot, the village shall issue a single sticker which shall be placed on a conspicuous place applied to the front windshield of the motor vehicle. ~~on the motor vehicle.~~ The designated employee sticker shall only be valid in the boat trailer lot and ~~the old main lift station lot parking lots lot #2.~~

5. No fees for parking in the boat/trailer parking lot shall be imposed on any person who has paid the launch access fees set forth in subsection (4), and who possesses a receipt for such payment, or a season pass sticker. There shall be no overnight parking without a valid launch receipt displayed for the date in which the vehicle and empty trailer are parked in the designated lot. No boats are allowed on the trailers for this provision. In addition all unattached trailers without a vehicle will be towed at the owner's expense.

6. Vehicles without a trailer and without an employee or resident parking sticker, may only use the single spot parking stalls and must have a valid parking lot receipt displayed for the current day between the hours of 6:00am and 8:00pm.

b. Parking-lot tickets shall not be accepted as free access to the beach.

c. Notwithstanding the provisions set forth in subsection (d)(5)a., the following annual fee shall be charged the following for the use of the parking lots; referred to in this subsection:

1. For a resident or a property owner of the village not using the village launch facilities, said fee shall be determined by the board.

~~2. For a resident or property owner of the Big Foot School District, said fee shall be determined by the board.~~

d. Upon payment of such sums, the village shall issue not more than ~~two~~ four stickers per parcel eligible resident or property owner, which shall be placed in a conspicuous place on the motor vehicle. ~~applied to the front windshield of the motor vehicle.~~

Section II.

Section 54-165 (a) shall be repealed and recreated to read as follows:

Section 54-165 Parking and mooring of watercraft at municipal pier regulated.


(a) No person shall park or moor any boat or watercraft at any of the municipally owned piers for a time in excess of two hours, except that no person shall park or moor any boat or watercraft at any time on the Village's launch ramp pier or any portion of the pier that is leased, with the exception of the leasee. In addition, only village residents shall park or moor any boat or watercraft at piers designated for resident parking only but must first obtain and affix to the boat or watercraft a resident sticker. This provision shall not apply to boats or watercraft operated by a duly authorized water safety patrol and law enforcement personnel.

Section III. Effective Date: This Ordinance shall be in full force and effect upon its passage, approval and publication as required by law.
