

## Ordinance 08-02-10-02

### An Ordinance Amending Section 6-13 (a) of the Village of Fontana Municipal Code Regarding Operator's licenses.

The Board of Trustees for the Village of Fontana on Geneva Lake, Walworth County, Wisconsin, do ordain as follows:

**Section 1.** Section 6-13 (a) shall be amended to read as follows:

**Sec. 6-13.** ~~Favern~~ Operator's license.

(a) An alcohol beverages operator's license as provided by ch. 125.17, Wis. Stats., may be issued by the village board of trustees to persons who have met the following criteria. Applicants must:

- (1) Be at least 18 years of age pursuant to § 125.68(2), Wis. Stats.;
- (2) Have completed a responsible server training course pursuant to § 125.04 (5)(a)(5), Wis. Stats.;
- (3) Not be a habitual law offender or be convicted of a felony unless the person has been duly pardoned pursuant to § 125.04(5)(b), Wis. Stats.;
- (4) Not have two or more alcoholic beverage/liquor related convictions or pending charges within five years of applying to be considered a habitual law offender;
- (5) Not be under a court order for alcohol assessment/treatment without the written consent of the counselor to apply for an operator license;
- ~~(6) Not been convicted of a felony or have pending felony charges which relates to alcoholic beverages/liquor pursuant to § 125.04(5)5(b) Wis. Stats.;~~
- (76) [Have] Completed a written application to the village clerk containing no false or misleading information;
- (87) Not be under any court or Department of Corrections conditions prohibiting the applicant from selling, possessing, or using alcoholic beverages or being on a licensed premise [premises];
- (98) Not [have] been convicted of any state or federal charge of manufacturing or delivery (or intent to) of a controlled substance.

The written application filed with the village clerk shall state the name, residence, age, and sex of the applicant and other information as may be deemed relevant and necessary. The applicant shall have his or her photograph taken by the village upon submission of the application, which shall be permanently filed with the village. Operator's licenses shall be ~~operative~~ valid only within the limits of the village. The application shall be referred to the chief of police for a report.


**Section 2. Effective Date:** This ordinance shall be in full force and effect upon its passage approval, and publication as required by law.


