

**Ordinance 09-09-13-02**

**An Ordinance Amending Sections 46-1, 54-161(a) and 74-51, & Creating Section 46-2 of the Village of Fontana Municipal Code Regarding Village park definitions.**

The Board of Trustees for the Village of Fontana on Geneva Lake, Walworth County, Wisconsin, do ordain as follows:

**Section 1.** Section 46-1 shall be amended to read as follows:

Sec. 46-1. - Park hours.

No person shall be in the village park between 11:00 p.m. and 6:00 a.m. The Duck Pond Recreation Area shall be closed from 10:00 p.m. to 7:00 a.m., unless there are special circumstances or approved special events. The hours of operation for all other village parks shall be set by the Village Board and subject to change on a temporary basis by Village staff. No unauthorized person shall be in a park in violation of the posted hours.

**Section 2.** Section 46-2 shall be created as follows:

Sec. 46-2. – Definitions

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Park means any beach, park, playground, athletic field or space owned, leased by or under control of the village, and as listed in the Village of Fontana Park and Open Space Plan and Comprehensive Master Plan.

**Section 3.** Section 54-161(a) shall be amended to read as follows:

Sec. 54-161. - General regulations.

(a) *Definitions.* The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this subsection, except where the context clearly indicates a different meaning:

*Parking area* means that portion of the property owned by the village which is used as a public parking lot and for which a charge is made on certain days for parking a vehicle.

*Public beach* means that portion of the shore of Geneva Lake which is owned by the village and which is enclosed by a ~~wire~~ fence or wall.

**Section 4.** Section 74-51 shall be amended to read as follows:

Sec. 74-51. - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Motor-driven vehicle* means any vehicle propelled by any type of motor, whether gasoline, electric or any other type of mechanized power, except maintenance equipment.

*Park* means any beach, park, playground, athletic field or space owned, leased by or under control of the village, and ~~not specifically designated by signs as a parking lot.~~ as listed in the Village of Fontana Park and Open Space Plan and Comprehensive Master Plan.

**Section 5.**     **Effective Date:** This ordinance shall be in full force and effect upon its passage approval, and publication as required by law.
