

**ORDINANCE NO. 11-01-05-02**

**An Ordinance Amending the Boundaries of the  
Extraterritorial Zoning Jurisdiction of the  
Village of Fontana-on-Geneva Lake Pursuant to  
Section 62.23(7a) Wis. Stats.**

**WHEREAS**, the Village of Fontana did previously adopt an extraterritorial zoning ordinance establishing an area of extraterritorial zoning jurisdiction; and

**WHEREAS**, subsequently the Village did receive a petition to amend the extraterritorial zoning boundaries pursuant to the procedures specified in Section 62.23(7a) Wis. Stats.; and

**WHEREAS**, the Village Board did previously adopt Resolution No. 7/11/05-1 initiating the process of amending the extraterritorial zoning boundaries for the Village of Fontana-on-Geneva Lake pursuant to the previously filed petition so as to include the area described more specifically in Exhibit "A", attached hereto and incorporated herein by reference; and

**WHEREAS**, thereafter the extraterritorial joint committee, pursuant to the requirements of Section 62.23(7a) Wis. Stats., did hold a public hearing and make a recommendation in favor of the proposed amendment to the extraterritorial zoning boundaries for the Village of Fontana-on-Geneva Lake; and

**WHEREAS**, thereafter the Plan Commission, pursuant to the requirements of Section 62.23(7a) Wis. Stats., did hold a public hearing and make a recommendation in favor of the proposed amendment to the extraterritorial zoning boundaries for the Village of Fontana-on-Geneva Lake; and




**NOW, THEREFORE**, the Village Board for the Village of Fontana-on-Geneva Lake does ordain as follows:

A PARCEL OF LAND LOCATED IN THE NORTHWEST 1/4 AND NORTHEAST 1/4 OF SECTION 17, TOWN 1 NORTH, RANGE 17 EAST, WALWORTH COUNTY, WISCONSIN.
